An **EAP** can be tailored to the unique needs of any business or organization. **EAP** contractual packages may include one or more of the following: drug testing for *pre-employment, random, Department of Transportation (DOT) violations or post-accident*:

- ⇒ **Certified Substance Abuse Professional Service** clinical evaluation, referral, and education/treatment mandated by the DOT for employees who violate DOT drug and alcohol regulations while performing safety-sensitive duties.
- ⇒ **Comprehensive Laboratory Drug Testing with Medical Review Officer (MRO) 5-Panel**: cannabis, cocaine, amphetamines, opiates, and PCP for DOT and non-DOT employees. **Results within 5 days.**
- ⇒ **Comprehensive Laboratory Drug Testing without MRO 10-panel**: alcohol (ETG), amphetamines, barbiturates, benzodiazepines, cocaine, creatine, fentanyl, opiates, oxycontin, and marijuana; **5-Panel**: cannabis, cocaine, amphetamines, opiates, and PCP. **Results within 5 days.**
- ⇒ **In-House Drug Testing** 13-panel Urine screen to detect (**Immediate results**)
- ⇒ **Professional Counseling for Employee (Individual sessions)**
- ⇒ **Drug Policy Development** Assistance with developing Drug Policy
